

BHM Capital Financial Services — Private Joint Stock Company Invitation to Shareholders to Subscribe to New Shares

BHM Capital Financial Services — Private Joint Stock Company (the "**Company**") is pleased to invite its esteemed shareholders to subscribe to the new cash shares resulting from the Company's share capital increase, which was approved by the General Assembly.

1. Capital Increase Resolution

The Company's General Assembly convened on 21 April 2025 and unanimously approved a resolution to increase the Company's share capital from AED 200,000,000 to AED 400,000,000 by issuing 200,000,000 new cash shares at a par value of AED 1 per share.

2. Capital Increase Value and Issue Price

- Amount of capital increase: AED 200,000,000
- Share capital after the increase: AED 400,000,000
- Number of new shares: 200,000,000
- **Issue price:** AED 1 per share (no share premium)
- **Eligibility:** Subscription is limited to shareholders registered as of the eligibility date, in proportion to their ownership as of that date.

- Purpose of capital increase: The primary objective of the proposed capital increase is to strengthen the
 Company's liquidity position and to support the execution of its strategic growth initiatives. The net
 proceeds from the capital increase are envisaged to be deployed as follows:
 - 20% Investment in technology infrastructure and digital transformation and Al.
 - O 25% Expansion into key regional markets
 - 25% Scaling market-making and liquidity provision capabilities
 - 30% Enhancing overall market liquidity and trading efficiency

This capital increase is expected to support the Company's long-term strategic direction and contribute to sustainable value creation, with an anticipated annual return on investment of approximately 25–30% over the next three years.

4. Subscription Terms

(A) Subscription Rights:

Shareholders registered in the shareholder register of BHM Capital Financial Services at the end of the trading day on (Thursday, 28 August 2025) (the "Eligibility Date"/Book Closure Date) are entitled to subscribe to the new shares in proportion to their ownership as of that date. Subscription rights are non-transferable, and cannot be sold or assigned.

(B) Subscription Period:

• Start Date: Monday, 8 September 2025

• End Date: Thursday, 18 September 2025

No subscription requests will be accepted after the closing date.

(C) Allocation Policy and Subscription for Remaining Shares:

Eligible shareholders may submit **one (1) subscription request** for the number of new shares they wish to subscribe to at the issue price of AED 1 per share—whether equal to or exceeding their entitlement.

Allocation will be as follows:

- 1. First: Proportional allocation to shareholders based on their ownership as of the eligibility date.
- 2. **Second:** If unsubscribed shares remain (due to unexercised rights or rounding), they will be proportionally allocated among those who requested more than their entitlement, based on the ratio of excess shares requested by each shareholder to the total excess requested.

Please note: Requesting more shares than entitled does not guarantee full allocation. Any excess subscription amount will be refunded within five (5) business days from the announcement of allocation results, to the bank account used for payment or via the same method of payment, as determined by the Company.

(D) Ownership Restrictions:

There are no ownership restrictions based on nationality.

Payment must be made via bank transfer to the Company's designated account (transfer receipt required). Refer to the subscription form for bank account details.

(G) Payment Amount:

Full payment for the subscribed shares is required at the time of submission.

(H) Allocation & Refund of Excess:

In case of partial allocation, the excess funds will be refunded within five (5) business days from the allocation date using the same method of payment or bank account used during subscription.

(I) Required Documents:
