

#### Invitation to the Annual Ordinary and Extra Ordinary General Meetings (1/ 2026)

The Chairman of the Board of Directors of Al Salam Bank B.S.C (the "Bank") CR number 59308-1, cordially invites the shareholders to attend the Bank's Annual Ordinary and Extra Ordinary General Meeting, to be held on Thursday, 12 March 2026, at 11:30 a.m. at Al Ghazal 3 Ballroom, Ritz Carlton Hotel, Seef District, Kingdom of Bahrain. As per the requirements of the Commercial Companies, in the absence of a quorum on the first scheduled date for the meetings, a second meeting will be scheduled on Thursday, 19 March 2026 at the same venue and time, and in the absence of quorum on such second date for the meeting a third meeting will be scheduled on Wednesday, 1 April 2026 at the same venue and time.

#### Agenda of the Annual Ordinary General Meeting:

- To approve the minutes of the previous Annual Ordinary General Meeting held on 19 March 2025.
- To discuss and approve the Board of Directors' report on the Bank's activities for the financial year ended 31 December 2025.
- To discuss the Shari'a Supervisory Board's report for the financial year ended 31 December 2025.
- To discuss the external auditors' report on the consolidated financial statements of the Bank for the financial year ended 31 December 2025.
- To discuss and approve the consolidated financial statements of the Bank for the financial year ended 31 December 2025.
- To report the transactions carried out by the Bank during the financial year ended 31 December 2025 with any related parties or major shareholders of the Bank as presented in the note (no. 30) to the consolidated financial statements in accordance with Article 189 of the Commercial Companies Law No. 21 for the year 2001 and its amendments.
- To approve the recommendations of the Board of Directors with respect to the following appropriations of the available net profit attributable to shareholders for the financial year ended 31 December 2025 as follows:
  - Transfer of BD 7,683 million to the statutory reserves.
  - Distribute a total Dividends of 15% of the issued and paid-up share capital of the Bank, amounting to BD 44,117 million, for the financial year ended 31 December 2025, as follows:
    - 8% as cash dividends, equivalent to 8 fils per share amounting to BD 23,344 million, excluding treasury shares;
    - 7% as bonus shares, amounting to BD 20,773 million - i.e. (1 share for each 14.3 shares held).
  - Retain BD 1 million for charitable donations and social welfare programs.
  - Transfer of the remaining balance of BD 13,028 million to retained earnings account.
- To approve remuneration to the members of the Board of Directors amounting to BD 1,300 million, for the financial year ended 31 December 2025.
- To receive and discuss the Bank's Corporate Governance Report for the financial year ended 31 December 2025, as required by the Central Bank of Bahrain and Ministry of Industry and Commerce.
- To absolve the members of the Board of Directors from any liability for their actions as directors during the financial year ended 31 December 2025.
- To reappoint the Shari'a Supervisory Board for the financial year ending 31 December 2026 and authorize the Board of Directors to determine their remuneration.
- To reappoint external auditors for the financial year ending 31 December 2026 and authorize the Board of Directors to determine their remuneration, taking in consideration that this appointment will be subject to the approval of the Central Bank of Bahrain.
- To discuss and approve any other matters that may arise as per Article 207 of the Commercial Companies' Law.

#### Agenda of the Extra Ordinary General Meeting:

- To ratify the previous minutes of the Extra Ordinary General Meetings held on 27 November 2025.
- To approve increase of the issued and paid-up share capital from BD 296,759,879 to BD 317,533,071 and the issued shares from 2,967,598,791 ordinary shares to 3,175,330,706 ordinary shares, resulting from the issuance of bonus shares amounting to 207,731,915 shares, in accordance with the resolutions of the Bank's Annual Ordinary General Meeting on 12 March 2026. This amendment will be subject to the approval of the Central Bank of Bahrain.
- To approve amending the Memorandum of Association and Articles of Association of the Bank to reflect the resolutions mentioned in items (2) and accordingly adopting an Amended and Restated Memorandum of Association and Articles of Association for the Bank. This amendment will be subject to the approval of the Central Bank of Bahrain and the Ministry of Industry and Commerce.
- To authorize the Chairman of the Board of Directors and/or the Bank's Group Chief Executive Officer, Mr. Rafik Nayed and/or Keypoint representative to individually carry out the necessary formalities, sign the Amended and Restated Memorandum of Association and Articles of Association of the Bank before the Notary Public and submit the relevant documents to the concerned authorities.
