During the year 2025, Drake & Scull International LLC – Oman (“DSI Oman”), a subsidiary of DSI PJSC with 51% ownership was liquidated. The liquidation process of DSI Oman was initiated by management in 2018 and completed during 2025 with notice published in official newspaper. The commercial registration of DSI Oman was cancelled with approval from ministry of commerce Oman.

On liquidation, a gain of AED 150.6 million was recognized out of which AED 28 million was attributed to shareholders of parent entity and AED 122.6million was attributed to non-controlling interest.
