Summary of the company's performance for the last financial year.

NGI's insurance revenue surpassed AED 1 billion mark in 2025 achieving 1.01 billion against AED 874.01 million in 2024, an increase of a 16% compared to FY 2024.

Insurance service results were AED 80.00 million an increase of 27.5% year-on-year, driven by enhanced pricing strategies and effective claims management

Investment income for the current year including movement in fair value of ULIP is AED 103.39 million compared to previous year investment income AED 120.97 million which includes one off gain from sale of investment property of 37.8 million.

Net profit of the Year 2025 is AED 117.65 million as against AED 127.50 million in 2024
