### **7-Summary of the company's performance for the last fiscal year.**

- ERC 's revenue increased by 33 % year-on-year (YoY) to 192 million AED in 2025, mainly driven by: -
  - a. Launched a new Direct Trade business vertical, enabling direct international sourcing and margin-optimized trade models across coffee, seafood, and FMCG commodities.
  - b. Entered global coffee trading through a strategic partnership with StoneX (listed company), marking the Group's expansion into institutional-grade commodity markets.
  - c. Launched eco-friendly paper cups and rPET products to significantly reduce plastic usage and advance sustainability goals, it marked a strategic shift towards sustainable packaging solutions, positioning the Group for future

- d. Established a cross-border coffee supply chain between the UAE and Uganda, strengthening origin-to-market capabilities and long-term sourcing security.
